1. This form is an important legal document. It is critical that you read and understand it completely. After you have done so, please print your name and sign in the spaces provided in the bottom of next page.

2. By signing the application form on this document parents and children agree to abide by the terms and conditions of "Highlands Coaching"

3. General

a. Correct tennis clothing must be worn at all times including footwear. The tennis professional will not allow a student to take a lesson if this condition is not met. However, the lesson will be charged as taken.

b. Parents/ Guardians are responsible to ensure their children bring a water bottle to facilitate proper hydration in sporting activity. They will also make sure their children wear a sun protective hat and sunscreen.

4. Coaching

a. All coaching services will be conducted by or under the supervision of qualified Tennis Australia and/or International certified coaches. "Highlands Coaching" is committed in providing a safe, professional and friendly environment for all to learn, improve their game and enjoy themselves. In registering for our programs all have access to a host of activities including, but not limited to: on court work –stroke development, tennis drills, games, match play, conditioning. They will also be able to access camps, specialty clinics and assignments and practices. All activities have inherent risks involved.

5. Safety

a. "Highlands Coaching" is committed to providing a safe environment for all, in doing so the following is to be followed:

i. Parents/ Guardians are responsible for the safe delivery and collection of students. Prompt pick-up following the completion of all sessions is expected. Please advise the coach director if any delay is anticipated.

ii. Parents/ Guardians are also responsible for ensuring that the coach is advised of any pre-existing illness or injury before the start of the session.

iii. Children aged 12 and under must be supervised by an adult. Babies and toddlers are not allowed inside the court area without previous consent by the coaching team. Parents at all times are responsible for the behavior of their children. For safety reasons any children not taking part in the session must not be on the coaching court at any time during the classes.

6. Behavior

a. All students are expected to behave in a manner in which encourages all to enjoy themselves. If any students causes disruption or disturbances in such that the coach feels that the safety and enjoyment of others is likely to be jeopardized that student may be excluded from on court activities.

7. Non attendance and Cancellation

a. Absence from a paid private lesson without informing the coach director at least 24 hours prior to the lesson, will not entitle the player to a catch up session. If an unpaid private lesson is absent without informing the coach director or cancels within 24 hours, a penalty of a full lesson fee will be charged.

b. Private and group lesson packages are based on a number of classes at a fixed time. If the student does not show up for the lesson, he or she will lose the right for a makeup lesson.

c. In the exceptional case the student is sick and cannot attend a lesson, the situation should be notified by email whereby the professional will reschedule the lesson/s up to 30 percent of the total amount of lessons

programmed. Notification should be made at least 12 hours in advance and a Medical Certificate must be provided.

d. "Highlands Coaching" will notify the student's parents if the lesson needs to be rescheduled due to weather conditions, holidays, or any other circumstances that will not allow the professional to be present for the lesson. This notification will be done by email or SMS as soon as the circumstances arises.

8. Assessment and Trial lessons

a. A trial lesson or class will be granted to assess the suitability of the student into the program. "Highlands Coaching" reserves the right to admit or deny the admission into a group or class depending on availability and professional criteria. After the trial lesson occurred, no refunds will be given in the event of cancellation.

9. Media Content

a. "Highlands Coaching" abides by the code of conduct as set out in the Privacy Act of 1988 and as updated. Your personal information will only be used in accordance with "Highlands Coaching" database and client management needs.

b. Photographs and results from competitions may be used to promote classes and events for publicity purposes including web site and media without compensation. By signing this waiver I hereby grant "Highlands Coaching", its director, employees and designees, non-revocable permission to capture "my own/ or my children's" image and likeness in photographs, videotapes, motion pictures, recordings, or any other media (collectively "images").

c. I acknowledge that "Highlands Coaching" will own such images and further grant permission to display, publish, distribute, use, modify, print such images in any matter whatsoever related to "Highlands Coaching" business, including without limitation publications, advertisements, brochures, web site images, or any other electronic displays.

10. Assumption of Risk

a. By signing this waiver I recognize I have volunteered to sign up or signed my children up to participate in a program of physical exercise under the direction of "Highlands Coaching" which will include, but may not be limited to cardiovascular or resistant training. I do here and forever release and discharge and hereby hold harmless, "Highlands Coaching" and their respective directors, employees and designees from any and all claims, demands, damages, rights of action or causes of action, present or future, arising out of or connected with my or my children's participation in this or any exercise program.

i. I recognize that exercise might be difficult and strenuous and that there could be dangers inherent in exercise for some individuals.

ii. I acknowledge that the possibility of certain unusual physical changes during exercise exist.

iii. I understand that physical contact is part of this exercise program and done by a professional in an instructional manner.

iv. I understand that as a result of my or my children's participation in an exercise program, Myself or they could suffer an injury or physical disorder.

b. I recognize that all participants, prior to involvement in any exercise program, should obtain an examination and clearance to participate by a physician.

i. If I have chosen not to obtain a physician's permission prior to beginning this exercise program, I hereby agree that I am doing so at my own risk.

c. In any event, I acknowledge and agree that I assume the risks associated with any and all activities and or exercises in which myself or they participate.

11. Fees

a. An invoice will be emailed to email address provided before commencement of the new term, with payments due within 7 days of issuing date. A late payment charge of \$15 will be added if fees are not paid by the due date. If fees are not paid within 10 days of the due date the student's position will be cancelled. Fees are payable by cash, bank transfer, genie solutions software or cheque payable to "Highlands Coaching". Returned cheques will attract a minimum charge of \$30.
